ORDINANCE NUMBER FIFTY-SIX

APPROPRIATION OF FUNDS FOR WATER SYSTEM IMPROVEMENT

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MILLS:

SECTION 1 .-- NECESSITY FOR IMPROVEMENT - EMERGENCY DECLARED TO EXIST.

INADEQUACY OF PRESENT EQUIPMENT. That, whereas the water pumping equipment owned and operated by the town of Mills, and furnishing all water for the municipal water system at the present time, having been in operation for somewhat more than twenty years, is worn to the point of being no longer reliable; and whereas the town of Mills does not possess auxiliary equipment to be operated in case of a breakdown of the said pump, further dependence upon the same for all waters supplied to the town of Mills has now become an extremely hazardous proceedure; and that, the present pump-house being inadequate for the accommodation of the larger pumping equipment now necessary, the same can no longer be depended upon without alteration for the housing of the town water pump; and that the foregoing conditions are such as to create an emergency in the town of Mills.

EMERGENCY DECLARED. That an emergency is, therefor, now hereby declared to exist.

SECTION 2. -- TRANSFER OF MONEY FROM GENERAL FUND TO WATER FUND

MONEY TO BE TRANSFERRED AND USED FOR IMPROVEMENT OF WATER SYSTEM. That, because of such emergency as hereinabove expressly set forth and explained, the sum of \$400.00 shall be transferred from the general fund of the town of Mills to the Mills water fund; the same to be appropriated, and expended, as hereinafter provided, for general improvements necessary, and hereinafter specifically enumerated, to be made upon the town water pumping equipment of the town of Mills.

SECTION 5. -- MONEYS TO BE RETAINED IN THE GENERAL FUND.

USUAL APPROPRIATIONS FROM THE GENERAL FUND PROVIDED FOR. That the sum of \$300.00 shall remain in the town general fund, appropriated, and to be expended, as follows: salary of Police Judge, at \$5.00 per month, for the months of September, October, and November, December, in the year of 1943, and the months of January, February, March and April, in the year of 1944, \$40.00; salary of Town Clerk, at \$5.00 per month, for the same above enumerated months, \$40.00; salary of town marshal, at \$5.00 per month, for the same months, \$40.00; maintenance of streets, from the present time until the end of the present fiscal year, April 30th, 1944, \$120.00; miscellaneous, small expenditures which may become necessary during the same period, \$60.00.

APPROPRIATION OF FUNDS FOR WATER SYSTEM IMPROVEMENT (Continued)

SECTION 4. -- APPROPRIATION MADE FROM WATER FUND.

USUAL APPROPRIATIONS FOR SALARIES AND MAINTENANCE PROVIDED. That the sum of \$1160.00 shall be appropriated to provide salary for the town Water Commissioner, at \$145.00 per month, for the months of September, October, November and December, in the year of 1943, and the months of January, February, March and April, in the year of 1944; the sum of \$160.00 to provide salary for the Town Treasurer, at \$20.00 per month, for the same months; the sum of \$85.00 to provide wages for an extra pump man to be employed about one half day per week, at approximately \$2.60 per half day, for the months above enumerated; and the sum of \$792.00 for operation and maintenance of the town water system, from the present time until the end of the present fiscal year; all such appropriations to be made from the Mills water fund.

SPECIAL APPROPRIATIONS FOR WITTH SYSTEM IMPROVEMENT. That the sum of \$750.00 for the purchase of a new water pump and appurtenances to same for the municipal water system; the sum of \$700.00 for the purchase of a power unit with accessories thereto, with which to operate said water pump, the same to be purchased at the discretion of the Town Council, or said sum to be held in reserve for future purchase of power unit as specified; and the sum of \$650.00 to be expended in such manner as the Town Council shall deem wise, to provide additional pump-house space to accommodate the above named equipment; all to be taken from the water fund of the town of Mills, also are hereby appropriated.
