

ORDINANCE 565

AN ORDINANCE ESTABLISHING WATER RATES FOR THE
TOWN OF MILLS, NATRONA COUNTY, WYOMING.

WHEREAS increased costs to the Town of Mills have created a situation which significantly increases the cost of producing water, and

WHEREAS the Town must increase the reserve fund for emergency repair and replacement of the water system and that fund has not grown as fast as the cost of those potential repairs:

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING:

SECTION 1 ANNEXED RESIDENTIAL PROPERTIES:

Water rates for residential properties annexed to Mills are hereby established to be \$15.00 ~~\$12.00~~ per quarter basic charge for 4,000 gallons of water use, with a charge of \$1.10 per one thousand gallons of use over the base of 4,000 gallons. ~~(The current rate is \$12.00 per quarter and \$1.10 per thousand gallons over the minimum of 4,000)~~

SECTION 2 ANNEXED COMMERCIAL PROPERTIES:

Water rates for commercial properties annexed to the Town of Mills are hereby established to be \$30.00 ~~\$27.60~~ per quarter basic charge for 6000 gallons of water use with a charge of \$1.40 ~~\$1.36~~ per thousand gallons of use over the base of 6000 gallons. ~~(The current rate is \$27.60 per quarter and \$1.36 per thousand gallons over the minimum of 6000 gallons.)~~

SECTION 3 EXTRA-TERRITORIAL RESIDENTIAL:

Water rates for residential properties outside of town limits are one and one half times the in town rate, or \$22.50 ~~\$18.00~~ per quarter basic charge for 4,000 gallons and \$1.65 for every thousand gallons used over the minimum of 4,000 gallons.

SECTION 4 EXTRA-TERRITORIAL COMMERCIAL:

Water rates for commercial properties outside the town limits are one and one half times the in town rate, or \$45.00 ~~(\$41.50)~~ per quarter basic charge for 6,000 gallons and \$2.10 ~~(2.05)~~ for every thousand gallons used over the minimum of 6,000 gallons.

SECTION 5 EFFECTIVE DATE:

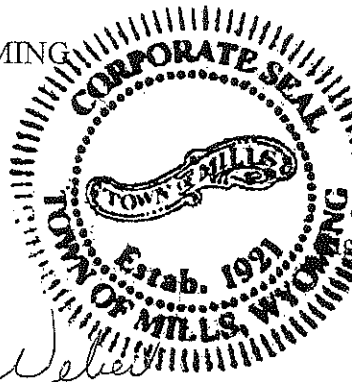
The water rates hereby listed shall become effective October 1, 2010.
