Chapter 2.04

AN ORDINANCE AMENDING SECTION 2.04.010 OF THE TOWN OF MILLS MUNICIPAL CODE PERTAINING TO TIME AND PLACE OF COUNCIL MEETINGS

WHEREAS the Town Council wishes to change the time of its regular meetings, and provide for work sessions, and;

WHEREAS it is necessary to provide a procedure to hold the regular meetings of the Mills Town Council on an alternate date in cases where the Mayor or other council members cannot attend the regular meetings, and

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING SECTION 2.04.010 OF THE MILLS MUNICIPAL CODE IS HEREBY AMENDED AS FOLLOWS:

2.04.010 Time and place of meetings.

- (A) Regular meetings of the town council shall be held on the first ~~second~~ Wednesday of each month, unless the first ~~second~~ Wednesday falls upon the first or second day of the month a legal holiday as defined by the Wyoming State Legislature, in which event the regular meeting shall be held on the second following Wednesday of the month. Regular meetings shall commence at seven o'clock 7:00 p.m. and be held at the council chambers, 704 according to law. (Ord 517 §1, 200
- (B) In the event the Mayor or a quorum of regular meeting of the Town Council reason, the Council may elect to hold determined by the Council. - (C) In the event the Council desires Council shall specify the date, the regularly scheduled Council meeting of each month.

(D) The Town Council will hold work sessions commencing at 9:00 AM on the Tuesday before the Wednesday regular meetings. In the event such Tuesday falls upon a legal holiday as defined by the Wyoming State Legislature, the work session will be held on the first Tuesday before the regular meeting which is not a legal holiday. Work sessions shall be for the purpose of discussion, deliberation and presentation of information to the Council, however no actual votes shall be taken upon any motion, proposal, resolution, regulation, rule, order or ordinance at any work session. Work sessions shall be open to the public.
