

ORDINANCE 578

AN ORDINANCE VACATING BUSH AVENUE WHICH INTERSECTS WITH
POISON SPIDER ROAD AND HANSEN AVENUE WITHIN THE HANSEN
ADDITION, AN ADDITION TO THE TOWN OF MILLS,
NATRONA COUNTY, WYOMING

WHEREAS the Town of Mills is authorized, pursuant to Wyoming Statute 15-6-104, to vacate streets and alleys or portions thereof within the Town of Mills; and

WHEREAS the Town Council of the Town of Mills has determined that it is in the best interest of the Town to vacate Bush Avenue within the Hansen Addition and more particularly described in the attached Property Location Plat, (EXHIBIT A); and

WHEREAS the Town Council of the Town of Mills has determined that due to replat of the Hansen Addition from nine lots to three lots, the vacation allows for larger Developing Business lots and relieves the Town's obligation to maintain the portions of the street so vacated;

NOW, THEREFORE BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING:

Section 1:

Bush Avenue is hereby vacated by the Town of Mills, Natrona County, Wyoming.

Section 2:

The vacation of Bush Avenue within the Town of Mills shall become effective immediately upon passage of this Ordinance.
