

ORDINANCE NUMBER FIFTY-EIGHT

THE ANNUAL APPROPRIATION ORDINANCE FOR THE NEXT FISCAL YEAR
(Beginning May I, 1944, and Ending April 30, 1945.)

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MILLS, WYOMING:

SECTION I-- APPROPRIATION FROM GENERAL FUND. That there is Hereby Appropriated from the General Fund of the Town of Mills, for the Purpose of Defraying the Expenses of the Town During the Next Fiscal Year, the Following Sums, to Wit:

SECTION 2.---- APPROPRIATION FROM WATER FUND. That there is Hereby Appropriated from the Water Fund of the Town of Mills, for the Purpose of Defraying the Expenses of the Department for the Next Fiscal Year, and for the Purchase of Necessary New Equipment and Repairs, the Following Sums, to Wit:
