AN ORDINANCE AMENDING ORDINANCE 312, ZONING, ADOPTED JUNE 1, 1981, CHANGING THE DISTRICT DESIGNATION OF LOT 1, SISCO ADDITION IN THE TOWN OF MILLS FROM ESTABLISHED RESIDENTIAL AND ESTABLISHED BUSINESS TO ESTABLISHED INDUSTRIAL WITHIN THE TOWN OF MILLS, NATRONA COUNTY, WYOMING

The Zoning District designation of Lot 1, SISCO ADD. is hereby changed from Established Residential and Established Business to Established Industrial.

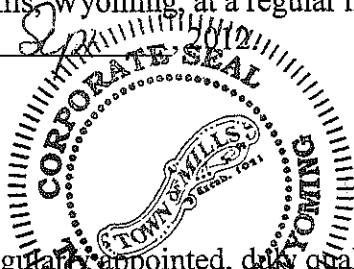
