

ORDINANCE NO. 594

AN ORDINANCE ADDING A SECTION TO THE MILLS MUNICIPAL CODE,
TITLE 13 PUBLIC UTILITIES OF THE MILLS MUNICIPAL CODE,
CHAPTER 13.04 WATER, WITHIN THE TOWN OF MILLS,
NATRONA COUNTY, WYOMING.

WHEREAS increased administrative and utility costs of starting and stopping water service within the Town of Mills has created a need to revise our billing procedures; and

WHEREAS the Town of Mills strives to ensure the lowest cost to all the citizens within the town of Mills; and

WHEREAS the Town of Mills must adopt this section of the municipal code to ensure all citizens pay fair costs of water distribution within the town; and

WHEREAS the Town of Mills is adopting this code to update and repair old water meters to ensure accuracy and inspect for cross connections to ensure water safety; and

WHEREAS the Town of Mills is adopting this new section within the municipal code to ensure timeliness and accurate water bills to adequately provide water for the growing needs of the Town and is added to the Mills Municipal Code, Title 13 Public Utilities, as follows:

13.04.320 Right of Access

It shall be unlawful for any person to refuse to give permission to the Town or its authorized agents to enter any premises where service is being received at all reasonable hours for the purpose of installing, reading, operating, inspecting, repairing or removing any or all apparatus used in connection with the supply and metering of water. If access is denied, water service will be turned off by the public works director or a licensed water operator. Any person violating this ordinance may be punished as provided by Ordinance 1.01.110.

NOW, THEREFORE BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING that the following section of Title 13 Public Utilities, 13.04 Water, Section 13.040.320 of the Mills Municipal Code is added to the Mills Municipal Code.




