ORDINANCE NO. 595

AN ORDINANCE AMENDING SECTION 2.16.010 OF THE MILLS MUNICIPAL CODE PERTAINING TO THE HOURS OF SERVICE AND COMPENSATION FOR THE OFFICE OF MAYOR.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERING BODY OF THE TOWN OF MILLS, WYOMING.

SECTION 1: SALARY OF MAYOR/HOURS OF SERVICE

The Mayor to the Town of Mills, Wyoming is expected to devote a minimum of 20-30 hours of service per week in the Town of Mills, Wyoming. The salary to be paid to the Mayor of the Town of Mills shall be Fourteen Thousand Four Hundred Dollars (\$14,400.00) monthly installments of One Thousand Two Hundred Dollars (\$1200.00) Twenty One Thousand Six Hundred Dollars (\$21,600.00) per year, payable in twelve (12) equal monthly installments of One Thousand Eight Hundred Dollars (\$1800.00). In the event the Mayor does not work the minimum number of hours for the Town of Mills, Wyoming prescribed in this section, and the salary of the Mayor shall be reduced in proportion to the number of hours actually worked.

SECTION 2: EFFECTIVE DATE

This Ordinance shall be in full force and effective ten (10) days following its passage and approval on third and final reading: however, the provisions of this Ordinance shall not be given retroactive effect with regard to any Mayor duly elected and serving at the time of the passage of this Ordinance.

SECTION 3: REPEAL OF CONFLICTING ORDINANCES

All existing Ordinances or parts of Ordinances of the Town of Mills affecting the Mayor's Salary are hereby repealed insofar as they may be inconsistent with the provisions of this Ordinance.
