ORDINANCE NO. 598 AN ORDINANCE AMENDING ORDINANCE 9.04.050 OF THE MILLS MUNICIPAL CODE PERTAINING TO DISCHARGING FIREARMS WITHIN THE TOWN LIMITS

WHEREAS, the Town of Mills, Wyoming desires to prohibit the discharge of firearms within the Town limits while authorizing the use of firearms at any bona fide shooting range(s) approved by the Town Council to promote economic development of new businesses within the Town; and

WHEREAS, the public health, safety and welfare of the Town of Mills, Wyoming will be served by the amendment of Ordinance 9.04.050 as provided herein.

NOW THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING:

Section 1. Ordinance 9.04.050 of the Mills Municipal Code is hereby amended as follows:

No person shall discharge any firearm, gun or other projectile by explosion, gas propulsion, spring propulsion, pressure propulsion, or by any other means of propulsion within the limits of the town except in self-defense or, in the case of a civil officer or a member of the Armed Forces of the United States of America or the state in the discharge of his official duty. This ordinance shall not prohibit any person from discharging any firearm in any bona fide shooting range duly authorized by the Town Council.

Section 2. Effective Date.

This ordinance shall be in full force and effect ten (10) days following its passage and approval on third and final reading.

Section 3. Repeal of Conflicting Ordinances.

All existing Ordinances or parts of Ordinances of the Town of Mills, Wyoming are hereby amended or repealed insofar as they may be inconsistent with the provisions of this Ordinance.
