ORDINANCE NO. 603

AN ORDINANCE AMMENDING ORDINANCE 420 ESTABLISHING WATER RATES FOR THE TOWN OF MILLS NATRONA COUNTY, WYOMING.

WHEREAS, increasing costs in the Town of Mill have created a situation which significantly increased the cost of producing water, and:

WHEREAS, the Town of Mills must increase the reserve fund for emergency repair and replacement of the water system and that fund has not grown as fast as the cost of those potential repairs, and:

WHEREAS, the Town of Mills strives to ensure the health and safety of the citizens of Mills, the Town must adopt the right to increase water rates to ensure a clean and safe water supply to grow the needs of the Town, and:

NOW THEREFORE ORDINANCE 420 is hereby amended as follows:

Section 1: Annexed residential Properties

Water rates for residential properties annexed to the Town of Mills are herby established to be \$ 18.00 per quarter basic charge for 4,000 gallons of water use, with a charge 0f \$ 1.35 per thousand gallons of use over the base of 4,000 gallons.

Section 2: Annexed Commercial Properties

Water rates for commercial properties annexed to the Town of Mills are hereby established to be \$ 36.00 per quarter basic charge for 6,000 gallons of water use, with a charge of \$ 1.65 per thousand gallons of use over the base of 6,000 gallons.

Section 3: Extra Territorial Residential Properties

Water rates for residential properties outside the Town limits are one and one half times the Town rate of \$ 27.00 per quarter basic charge for 4, 000 gallons of water use, with a charge of \$ 1.90 per thousand gallons of use over the minimum of 4,000 gallons.

Section 4: Extra Territorial Commercial Properties

Water rate for commercial properties outside the Town limits are one and one half times the in Town rate of \$ 54.00 per quarter basic charge for 6,000 gallons of water use, with a charge of \$ 2.35 per thousand gallons of use over the minimum of 6,000 gallons.

SECTION 1: The Town Council shall set water rates by resolution annually.

SECTION 2: Any adjustment in water rates shall not become effective until after the new rates have been posted at the Mills town Hall for a period of fifteen (15) days.
