ORDINANCE NO. 604

AN ORDINANCE AMMENDING ORDINANCE 587 ESTABLISHING SEWER AND SANITATION RATES FOR THE TOWN OF MILLS NATRONA COUNTY. WYOMING.

WHEREAS, increasing costs in the Town of Mill have created a situation which significantly increased the Town's sanitation costs, and:

WHEREAS, the Town of Mills considers it to be a significant improvement of service to providing owners and tenants with a pass to use the Casper Bale Fill through the Mills water bill, and:

WHEREAS, the Town of Mills strives to ensure the health and safety of the citizens of Mills, the Town must adopt the right to increase sanitation rates to ensure a clean and safe living environment to the growing needs of the Town, and:

WHEREAS, the Town of Mills will now set sanitation rates by resolution annually.

NOW THEREFORE ORDINANCE 587 is hereby amended as follows:

Section 1: Annexed Residential Sanitation Rates

Residential customers are hereby established to be \$ 39.60 for one 95 gallon container per 1 quarter emptied once per week.

Section 2: Annexed Commercial Sanitation Rates

Sanitation rates for the Town's commercial customers are hereby established to be \$ 39.60 for one 95 gallon container per quarter emptied once per week: \$ 90.00 for one 100 gallon container per quarter emptied once per week: and \$ 90.00 for a 3 yard bin per quarter emptied once per week.

Section 3: Use of the Casper Bale Fill

Each quarterly billing will contain three punches to be used by the payer of the bill at the Casper Bale Fill. These punches will allow the payer to haul trash and garbage to the Casper Bale Fill and dispose of it there with no additional charge. This program is subject to rules and regulations of the Casper Bale Fill concerning oversized loads, hazardous materials and other requirements.

Section 4: Effective Date

The sanitation rates hereby listed above shall become effective October 1, 2012.

SECTION 1: The Town Council shall set sewer and sanitation rates by resolution annually.

SECTION 2: Any adjustment in water rates shall not become effective until after the new rates have been posted at the Mills Town Hall for a period of fifteen (15) days.
