Ordinance No. 607

AN ORDINANCE TO ESTABLISH PROCEDURES AND AUTHORIZE THE ISSUANCE OF SATELLITE MANUFACTURER'S PERMITS.

BE IT ORDAINED BY THE MAYOR AND TOWN COUNCIL OF MILLS, WYOMING

WHEREAS The Town is authorized, pursuant to Wyoming Statutes 12-2-203 to issue manufacturer satellite permits, and

WHEREAS The Town desires to prescribe the manner in which a manufacturer satellite permits may be considered by the Town.

NOW THEREFORE BE IT ORDAINED BY THE TOWN OF MILLS AS FOLLOWS:

SECTION 1: A holder of a manufacturer's license issued by the State of Wyoming may dispense free of charge on-site samples of quantities not to exceed one and one half (1.5) ounces of their manufactured product and no more than two (2) samples per customer per day. The dispensing of samples shall be subject to the schedule of operating hour provided in W. S. § 12-5-101 and the dispensing room provisions provided in W. S. § 12-5-201 and shall be subject to term per W. S. § 12-4-106.

SECTION 2: Satellite manufacturer's permit. The Town of Mills, Wyoming, upon application, and after public hearing, may authorize issuance of a satellite manufacturer's permit to the holders of a manufacturer's permit pursuant to the provisions of W. S. § 12-2-203.

SECTION 3: Applications; procedures; fees.

Any person desiring a satellite manufacturer's permit to sell alcoholic liquors or malt beverages with in the Town shall file an application with the Town Clerk, including required supporting documentation and payment of applicable fees as follows:

Permit Type	Fee
<b>Satellite Manufacturer's Permit</b>	<b>\$ 100.00</b>

SECTION 4: If any portion of this Ordinance is held and found to be invalid, the remainder of the ordinance shall continue to be in full force and effect.

SECTION 5: This Ordinance shall take effect and in full force and effect ten (10) days after the passage on third reading.
