

ORDINANCE NO. 609

AN ORDINANCE CHANGING THE NAME OF THE PRIVATE DRIVE INTERSECTING ON THE WEST SIDE OF FULTON STREET TO RUSTEN, A DEDICATED ROADWAY WITHIN THE TOWN OF MILLS, NATRONA COUNTY, WYOMING

WHEREAS the Town wishes to name all streets and correct all addressing problems with in the town to facilitate rapid emergency response time to each home within the town; and

WHEREAS the Town is adopting the Natrona County Grid Addressing System as its standard: and

WHEREAS the Town is beginning to re-name duplicate named roads within the county and naming all private drives within the town; and

WHEREAS, the Town Council and Mayor have determined that changing the name is in the best interest of the town and by changing the name of this Private Drive, it will facilitate rapid emergency response time by EMS vehicles within the town,

NOW, THEREFORE BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING:

The private drive off Fulton Street heading west will be re-named to Rusten, and the county clerk will be notified, the town map will be corrected, and that a street sign will be posted after third reading.

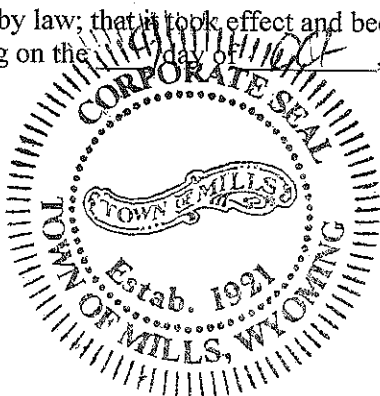
