

ORDINANCE NO. 615

AN ORDINANCE RATIFYING ORDINANCE NUMBERS 576, 577, 578, 579, 580, 581, 582, 583, 584, 586, 587, 588, 589, 590, 591, 592, 593, 594 AND 595 OF THE TOWN OF MILLS, WYOMING AND DECLARING AN EMERGENCY

WHEREAS the Town Council of the Town of Mills, Wyoming has previously read (by title only) at its public meetings Ordinance Numbers 576, 577, 578, 579, 580, 581, 582, 583, 584, 586, 587, 588, 589, 590, 591, 592, 593, 594 and 595 on three different days with at least ten days having elapsed between readings as required by W.S. §15-1-114, and

WHEREAS the Town Council of the Town of Mills, Wyoming has previously adopted, passed and approved Ordinance Numbers 576, 577, 578, 579, 580, 581, 582, 583, 584, 586, 587, 588, 589, 590, 591, 592, 593, 594 and 595 by affirmative vote of the majority of the qualified members of the governing body on three different days with at least ten days having elapsed between readings as required by W.S. §15-1-115, and

WHEREAS due to administrative oversight, Ordinance Numbers 576, 577, 578, 579, 580, 581, 582, 583, 584, 586, 587, 588, 589, 590, 591, 592, 593, 594 and 595 may have not been signed by the presiding mayor as required by W.S. §15-1-116, and

WHEREAS passage of this emergency Ordinance is necessary to correct any procedural irregularities and eliminate potential ambiguities in the event the ordinances identified herein were not signed by the mayor within a reasonable time after passage.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING:

SECTION 1:

Ordinance Numbers 576, 577, 578, 579, 580, 581, 582, 583, 584, 586, 587, 588, 589, 590, 591, 592, 593, 594 and 595 as previously adopted by the Town Council of the Town of Mills, Wyoming following public reading (by title only) and affirmative vote of the majority of the qualified members of the governing body on three separate days are hereby ratified and affirmed in all respects.

SECTION 2:

The mayor of the Town of Mills is hereby authorized and directed to sign Ordinance Numbers 576, 577, 578, 579, 580, 581, 582, 583, 584, 586, 587, 588, 589, 590, 591, 592, 593, 594 and 595 without changing the effective date of passage as originally adopted by the Town Council.

SECTION 3:

The Town Clerk of the Town of Mills is hereby authorized and directed to attest and post Ordinance Numbers 576, 577, 578, 579, 580, 581, 582, 583, 584, 586, 587, 588, 589, 590, 591, 592, 593, 594 and 595 without changing the effective date of passage as originally adopted by the Town Council.

SECTION 4:

Pursuant to W.S. §15-1-115, for an emergency Ordinance, the requirements relating to public readings and the ten (10) day elapse between introduction and passage may be suspended by the affirmative vote of three-fourths of the qualified members of the governing body; and, pursuant to W.S. §15-1-115(d), the passage of an emergency Ordinance requires the affirmative vote of three-fourths of the qualified members of the governing body.
