ORDINANCE NO. 616

AN ORDINANCE ADDING DWYER DRIVE AS A PUBLIC STREET WHICH
CONNECTS THE DLD SIMPLE SUBDIVISION IN SECTION 6, TOWNSHIP
33 NORTH, RANGE 80 WEST, 6TH PRINCIPAL MERIDIAN,
NATRONA COUNTY TO PROGRESS CIRCLE LOCATED IN
CENTER WEST PARCEL "B" SUBDIVISION WITHIN
THE TOWN OF MILLS, NATRONA COUNTY, WYOMING

WHEREAS the Town of Mills is posturing itself to grow and annex outward
into residential and business properties which will require the town to add streets
that will connect the town to portions of growing subdivisions and annexed growth
areas; and

WHEREAS the Town Council of the Town of Mills has initiated the
proposed street addition to the Town of Mills and has after review by the Planning
and Zoning Board and a public hearing, determined that the proposed additional
street named Dwyer Drive is in keeping with the proposed land use polices within
the Town; and

WHEREAS it is in the best interest of the Town of Mills, the Mills Fire
Department, the Mills Police Department, the residents of the area, and the public's
welfare to add Dwyer Drive as a public street connecting with Progress Circle;
therefore

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS,
WYOMING:

That this ordinance adding Dwyer Drive to the Town of Mills, Natrona
County, Wyoming, is approved and shall be recorded in the office of the Natrona
County Clerk.
