AN ORDINANCE AUTHORIZING THE VACATION AND REPLAT OF ALL OF LOTS 1 AND 2, BLOCK 4, OF MILLS ADDITION, TO BE KNOWN AS LOTS 17 AND 18, BLOCK 4 OF MILLS ADDITION LOCATED IN THE SW1/4 OF THE NE1/4 OF SECTION 7, TOWNSHIP 33 NORTH, RANGE 79 WEST, 6TH PRINCIPAL MERDIAN, NATRONA COUNTY, WYOMING.

WHEREAS the Town of Mills has received a request to vacate and replat all of Lots 1 and 2, Block 4 of the Mills Addition and replating said lots as Lots 17 and 18, Block 4 of the Mills Addition within the Town of Mills; and

WHEREAS the Mills Planning and Zoning Board conducted a public meeting on 7 November, 2014 and forwarded a "Do Pass" recommendation to the Town Council approving the Vacation of Lots 1 and 2, Block 4 of the Mills Addition and a Replat as Lots 17 and 18, Block 4 of the Mills Addition; and

WHEREAS the Mills Town Council conducted a public meeting on 19 November, 2014 considering the Vacation and Replat of the same lots; and

WHEREAS the Town Council of the Town of Mills has determined that it is in the best interest of the Town to vacate Lots 1 and 2, Block 4 of the Mills Addition and replat as Lots 17 and 18, Block 4 of the Mills Addition, Town of Mills situated in the Southwest Quarter of the Northwest Quarter (SW1/4NW1/4), of Section 7, Township 33 North, Range 79 West, 6th Principal Meridian, Town of Mills, Natrona County, Wyoming being more fully described as:

Beginning at the easterly most corner of said lot 1, thence North 46° 04' 59" West a distance of 80.08 feet to the northerly most corner of said lot 2,

thence South 43° 57' 38" West a distance 139.97 feet to the westerly most corner of said Lot 2,

thence South 46° 03' 01" East a distance of 80.00 feet to the southerly most corner of said Lot 1,

thence North 43° 59' 39" East a distance of 140.02 feet to the point of beginning,

WHEREAS said tract containing 0.257 acres more or less; and.

WHEREAS the Town Council of the Town of Mills has determined that due to this vacation and replat of these lots, that this will provide for a better use of the land, and is in keeping with the proposed land use polices within the Town; and

WHEREAS, and in accordance with the desires of the under-signed owner(s), as appears on this plat, is with free consent, and in accordance with the desires of the undersigned owner(s), proprietor(s) or parties of interest have by these presents laid out and surveyed as "Lots 17 and 18, Block 4 of the Mills Addition, Town of Mills" that all roads and streets as shown hereon have previously been dedicated to the use of the public and the name of the replat shall be "Better View Simple Subdivision".

NOW, THEREFORE BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING:

The Vacation and Replat of all of Lots 1 and 2, Block 4 of the Mills Addition, Town of Mills, Natrona County, Wyoming records to be known as Lots 17 and 18, Block 4, Town of Mills situated in the Southwest Quarter of the Northwest Quarter (SW1/4NW1/4), of Section 7, Township 33 North, Range 79 West, 6th Principal Meridian, Town of Mills, Natrona County, Wyoming and shall become effective immediately upon passage of this Ordinance.


