Ordinance No. 645

AN ORDINANCE TO AMEND ORDINANCE NO 465, APPEARING IN THE MILLS MUNICIPAL CODE AS SECTION 10.36.100 ENTITLED "RECREATIONAL VEHICLE PARKING- VIOLATIONS" AMENDING SUCH ORDINANCE TO CHANGE THE LENGTH OF TIME THAT AN ANNUAL PERMIT ALLOWS FOR A RECREATIONAL VEHICLE TO BE PARKED ON A PUBLIC STREET.

WHEREAS, W.S. §15-1-103 (v) authorizes the Town to perform all acts in relation to the property and concerns of the city or town necessary to the exercise of its corporate powers, and;

WHEREAS, W.S. §15-1-103 (xi) authorizes the Town to take all necessary action to plan, construct or otherwise improve, modify, repair, maintain and regulate the use of streets,

WHEREAS, W.S. §15-1-103 (xli) authorizes the Town to adopt ordinances, resolutions

and regulations necessary for the health, safety and welfare of the town

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING:

That section 10.36.100 of the Mills Municipal Code and Ordinance 465 of the Town of Mills is hereby amended to read as follows:

10.36.100. Recreational vehicle parking--Violation.

- It is unlawful and a violation of this chapter to park a recreational vehicle on any street within the town except as follows:
- The owner of any such recreational vehicle may apply to the town for an annual a permit to park a recreational vehicle on the public street in front of the lot owned by him. If the chief of police determines that there is insufficient space or access to the lot for storage of such unit, then he shall notify the applicant. who shall obtain the signatures of four of the five lots adjacent to and across the street from the applicant, agreeing to the parking of such recreational vehicle. The petition shall be presented to the chief of police before a permit to park on the street will be approved. The five lots shall mean the two lots immediately adjacent on the same side of the street (one on each side) and the three lots immediately across the street. A permit allowing parking of such vehicles shall not be issued for parking on an arterial or Collector Street, as designated by the chief of police.
- The owner of any boat, boat trailer, utility trailer, horse trailer, motor home, recreational vehicle. trailer van or similar type of vehicles shall be permitted to park such boat, boat trailer, utility trailer, horse trailer, motor home, recreational vehicle, trailer van or similar type vehicles on any street for a period not to exceed five consecutive days in any thirty day period. Any person desiring to park any boat, boat trailer. utility trailer, horse trailer, motor home, recreational vehicle, trailer van or similar type of vehicle on a street for a period in excess of five consecutive days in any thirty day period shall first obtain an RV parking permit set forth in subsection (a) (1) of this section.
- At any corner formed by the intersecting streets, it shall be unlawful to park within the triangle formed by the centerline of the intersecting streets, or alley drawn from the centerline of the intersecting streets or alley, drawn from the point of intersection back a distance of seventy-five feet with a line drawn to form a right triangle.
- Permits are good for one; five month consecutive period in a calendar year and can be renewed annually if no objections have been received from adjoining property owners. The fee for such permit or the renewal of the permit shall be as approved by a resolution of the council.
- The provisions of subsection (a) of this section shall not apply to storage in authorized trailer sales (b) or service facilities or garages or recreational vehicle parking areas.
- The use of a recreational vehicle as a dwelling when parked on private property or on a public street, shall be limited to five consecutive days, except when parked at any recreational vehicle park licensed by the town.
