

ORDINANCE NO. 653

AN ORDINANCE ESTABLISHING PARK

REGULATIONS

WITH IN THE TOWN OF MILLS, NATRONA COUNTY, WYOMING

WHERE AS the Town of Mills is authorized by W.S. §15-1-103 (a) (xi) to take all necessary action to plan, construct or otherwise improve, modify, repair, maintain and regulate the use of streets, alleys, bridges, parks , public grounds, cemeteries and sidewalks; and

WHERE AS the Town of Mills desires to adopt regulations pertaining to the use of public parks.

NOW, THEREFORE BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING CHAPTER 9.05 OF THE MILLS MUNICIPAL CODE IS HEREBY ESTABLISHED AS FOLLOWS:

9.05.010 Parks - hours of operation

Unless different hours are established as provided herein, all public parks within the Town of Mills shall be open to public use daily between the hours of six o'clock A.M through eleven o'clock P.M. The Mayor shall be authorized to issue temporary permits modifying the hours of operation to any person, firm or organization for good cause. Any person violating this section shall be guilty of a misdemeanor.

9.05.020 Parks - closures

Any park or section thereof may be declared closed at any time to the public by the Mayor or his duly authorized representative, and for any interval of time, as the Mayor or his duly authorized representative shall find reasonably necessary. Any person violating this section shall be guilty of a misdemeanor.

This ordinance amending the Mills Municipal Code shall be in full force and effect from and after passage on three readings and publication of this ordinance.

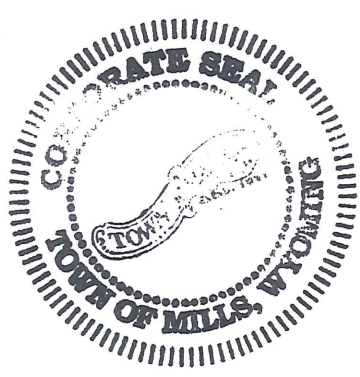
