

**ORDINANCE NO. 655**

AN ORDINANCE ADOPTING CHAPTER 12, SECTION 05 OF THE MILLS MUNICIPAL CODE PROHIBITING OBSTRUCTION OF STREETS, SIDEWALKS AND EASEMENTS.

WHEREAS, the Town of Mills is authorized pursuant to W.S. 15-1-103(a) (xi) to take all necessary action to regulate the use of streets, parks, public grounds and sidewalks; and

WHEREAS, it is necessary for the preservation of the safety, health, life and general welfare of the residents of the Town of Mills, to adopt ordinances necessary to prohibit the obstruction of streets, sidewalks and easements.

Now therefore, be it ordained by the Town Council of the Town of Mills, Wyoming that the following sections of the municipal code be created as follows:

Chapter 12.05

**OBSTRUCTIONS OF STREETS, SIDEWALKS AND EASEMENTS**

Sections:

- 12.05.010 Exempt obstructions designated.
- 12.05.020 Obstructions prohibited when
- 12.05.030 Penalty

**12.05.010 Exempt obstructions designated.**

Official police and public works barricades, refuse cans authorized by the town, streetlights, utility poles and fixtures, fireplugs, parking meters, and other similar obstructions because of necessity or by ordinance, are permitted to occupy space upon the sidewalk, street or easement and are exempt from the provisions of this chapter.

**12.05.020 Obstructions prohibited when.**

It is unlawful for any person owning, occupying or having control of any premises to place or permit upon the sidewalk, easement or the half of the street adjacent to such premises or easement:

- A. Any broken ware or glass, and filth, rubbish, refuse matter, ice, water, oil, mud, garbage, ashes, tin cans or other similar substances;
- B. Any automobile, truck or trailer from which merchandise is sold, or any automobile, truck or trailer on the sidewalk, any box or boxes, bicycle, toy, merchandise or other things that will obstruct the sidewalk, street or easement in any way; provided, that the town council shall be authorized, upon request for permission by any property owner, or any other person, to authorize temporary use of the streets, sidewalks or easements, if found justifiable by the town council and in the public interest.

**12.05.030 Penalty for Violation**

Any person, firm or corporation violating any of the provisions of this Ordinance is guilty of a misdemeanor and each person is guilty of a separate offence for each and every day or portion thereof during which any violation of any of the provisions of this Ordinance is committed, continued, or permitted. Any person found guilty of violating any of the provisions of this Ordinance shall be fined in any sum deemed appropriate by the Municipal Court of the Town of Mills not to exceed \$750 for each violation.
