ORDINANCE NO 665

AN ORDINANCE TO ESTABLISH FEES AND CHARGES FOR FALSE ALARMS FOR EMERGENCY SERVICES

WHEREAS, the Town of Mills Police and Fire departments responds to calls for emergency services, some of which are unfounded or false alarms.; and

WHEREAS, the Town of Mills has determined that unfounded or false alarms constitute a nuisance which disturbs or jeopardizes the public health, safety and welfare; and

WHEREAS, W.S. 15-1-103 (a) (c) (xix) authorizes the Town of Mills to declare and abate nuisances and impose fines upon parties who create, continue or permit nuisances to exist.

NOW, THEREFORE BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING SECTION 9.65.010 OF THE MILLS MUNICIPAL CODE IS HEREBY CREATED AS FOLLOWS:

9.65.010 - False alarms service charges.

- A. When the Mills Police or Fire department responds to a false alarm, the alarm user or person requesting emergency assistance shall be assessed a false alarm service charge. The service charges shall increase based upon the number of false alarms occurring within a period of twelve months. The service charges shall be established by resolution of the Town council.
- B. Service charges shall be due and payable after the occurrence of the false alarm, and are delinquent thirty days after notification of the service charge.
- C. Debt to Town. All fees and charges levied pursuant to this Ordinance shall constitute a valid and subsisting debt in favor to the Town of Mills, and against the alarm user or person requesting emergency service for whom services were rendered. If the amount remains unpaid, a civil action may be filed with the appropriate court for the amount due together with any penalties, and related charges and fees accrued due to nonpayment and all fees, costs, expenses and charges required to file and pursue such civil action, including reasonable attorney's fees.
- D. No business license shall be renewed to any user with an outstanding debt under this Ordinance.

NOW, THEREFORE BE IT FURTHER ORDAINED that upon passage and execution of this ordinance in accordance with the law, this ordinance shall be filed with the office of Natrona County Clerk.
