TOWN OF MILLS ORDINANCE No. <u>680</u>

AN ORDINANCE AMENDING TITLE 1 GENERAL PROVISIONS, OF THE TOWN CODE

WHEREAS, the Town of Mills is a duly authorized municipal corporation under the laws of the State of Wyoming;

WHEREAS, the Town of Mills has the authority under Wyoming State Statutes to pass laws to protect the citizens of the Town of Mills;

WHEREAS, the Town of Mills has determined the existing Title 1, General Provisions, should be repealed and brought current to be consistent with State law;

WHEREAS, the existing Title 1 of the Mills Town Code should be repealed in its entirety including all amendments;

WHEREAS, the Town of Mills has duly considered the various laws concerning the general laws of the Town; and

WHEREAS, the following shall be adopted in this ordinance and when passed shall be codified and incorporated as follows:

CHAPTER 1.01 IN GENERAL

1.01.010 - The Code of the Town of Mills.

This Code is and shall constitute the Code of the Town of Mills. The Code shall reflect and constitute codification of ordinances of Mills. (Ord. No. 680; 8-10-2016)

1.01.020 How Code Designated and Cited.

The ordinances embraced in this Chapter and the following Chapters and sections shall constitute and be designated as the "Code of the Town of Mills" and shall be cited as such. In this publication, and other documents, the "Code of the Town of Mills" may be referred to as the Town Code or Code. (Ord. No. 680; 8-10-2016)

1.01.030 Definitions and Rules of Construction.

- (a) In the construction of this Code and Ordinances of the Town of Mills, the following definitions and rules of construction shall be observed, unless they are inconsistent with the manifest intent of the Governing Body or the content clearly requires otherwise.
 - (i) Administrative Official The term "administrative official" shall mean a board, commission, committee, officer, agent or employee of the Town of Mills charged by the Governing Body with the administration and enforcement of the particular provisions of this Code in which the term is used.
 - (ii) <u>Computation of Time</u> The time within which an act is to be done shall be computed by excluding the day of the event and including the last day of the time period unless the last day is a Saturday, Sunday or a State of Wyoming legal holiday, in such case the period shall run until the end of the next day which is not a Saturday, Sunday, or legal holiday.
 - (iii) County The word "county" shall mean Natrona County in the State of Wyoming, in which the Town of Mills is located.
 - (iv) Gender Words importing the masculine gender include the feminine and neuter.
 - (v) <u>Governing Body</u> The term "Governing Body" shall mean the elected and serving legislative body of the Town of Mills.
 - (vi) In the Town; in the Corporate Limits of the Town The words "in the Town" or "in the corporate limits of the Town" shall mean and include any and all territory within the corporate limits of the Town of Mills, and other territory over which regulatory or police power has been conferred for the Town of Mills by general or special act of Natrona County, or the State of Wyoming.
 - (vii) <u>Joint Authority</u> All words giving joint authority to three or more persons shall be construed as giving such authority to a majority of such persons.
 - (viii) Month The word "month" shall mean the particular calendar month.
 - (ix) Municipality The word "Municipality" shall mean the Town of Mills.
 - (x) <u>Number</u> Words used in the singular include the plural and words used in the plural include the singular.
 - (xi) Oath The word "oath" includes an affirmation in all cases in which, by law, an affirmation may be substituted for an oath, and in such cases the words "swear" and "sworn" are equivalent to the words "affirm" and "affirmed".
 - (xii) Owner The word "owner" when applied to a building or land, shall include not only the owner of the whole, but also any part owner, joint owner, tenant in common or joint tenant of the whole or part of such building or land and shall include any agent of such owner, and where such owner is a body corporate, it shall include the managing agent or officers.

- (xiii) <u>Person</u> The word "person" includes a firm, partnership, association of persons, corporation, organization or any other group acting as a unit, as well as an individual.
- (xiv) <u>Personal Property</u> The term "personal property" includes every type of property, except real estate property which is defined later in this section.
- (xv) <u>Preceding, Following</u> The words "preceding" and "following" shall mean next before and next after, respectively.
- (xvi) <u>Property</u> The sole use of the word "property" includes real and personal property.
- (xvii) <u>Real Property</u> The term "real property" includes lands, tenements, and hereditament.
- (xviii) <u>Revision</u> Revision is to correct errors, make changes, and update the Municipal Code of Mills within existing Titles, Articles, and Sections.
- (xix) Shall The word "shall" is mandatory, and the word "may" is permissive.
- (xx) <u>Sidewalk</u> The word "sidewalk" means any portion of the street between the curb line and the adjacent property line intended for the use of pedestrians.
- (xxi) State The word "State" shall mean the State of Wyoming.
- (xxii) <u>State Law or State Statute</u> Reference to "state law" shall mean the Wyoming Statutes as amended.
- (xxiii) <u>Street</u> The word "street" shall mean and include public streets, avenues, boulevards, highways, roads, alleys, lanes, bridges and the approaches and all other public thoroughfares in the Town of Mills.
- (xxiv) <u>Tenant</u> The words "tenant" and "occupant" when applied to a building or land, shall mean any person who occupies the whole or a part of such building or land, whether alone or with others.
- (xxv) <u>Tense</u> Words used in the past or present tense include the future as well as the past and present.
- (xxvi) Written The words "written" or "in writing" shall include printing, lithographing, or other modes of representing words and letters; provided in all cases where the written signature of a person is required, the proper handwriting of such person, or his mark shall be required.
- (xxvii) Year The word "year" shall mean a calendar year, unless defined otherwise. (Ord. No. 680; 8-10-2016)

1.01.040 - Catch Lines; Headings.

The catch lines of the sections and the headings of Titles, articles, sections, and subsections of this Code are intended merely, and only, as catchwords to indicate and give guidance to the contents of the titles, articles, and sections. (Ord. No. 680; 8-10-2016)

1.01.050 Severability of Parts of the Code.

If for any reason any part, section, subsection, sentence, clause or phrase of the Code of the Town of Mills, or the application to any person or circumstance, is declared to be unconstitutional or invalid, such decision shall not affect the validity of the remaining portions of the Code of the Town of Mills. In the event any part, paragraph, clause or section of the Code of the Town of Mills is declared by a court of competent jurisdiction to be invalid for any reason, it is declared and determined the Mayor and Governing Body would nevertheless have passed the

remainder and the remaining parts shall remain in full force and effect. (Ord. No. 680; 8-10-2016)

1.01.060 - Effect of Repealing Ordinance.

The repeal of ordinances as provided shall not effect any right which has accrued, and duly imposed, any penalty incurred, nor any action or proceedings as commenced under or by virtue of the ordinance repealed, nor the tenure of office of any person holding office at the time when such ordinances take effect; nor shall the repeal of any ordinances have the effect of reviving any ordinance repealed or superseded; nor shall the repeal of any ordinance have the effect of giving meaning for the purposes of construction of any ordinance repealed or superseded. (Ord. No. 680; 8-10-2016)

1.01.070 Preserving and Recording Ordinances.

It shall be the duty of the Town Clerk to safely preserve the original ordinances, and when passed and approved to record the same in a book provided for that purpose. The Town Clerk shall attach a certificate to each ordinance, so recorded, to the effect the same is a true and correct copy of the original ordinance as passed. (Ord. No. 680; 8-10-2016)

1.01.080 Updating Code.

The Town Clerk twice yearly, or more often, shall compile amendments, changes, alterations, repeals or additions to the Code of the Town of Mills, which shall be submitted to an appropriate publisher or designated individual for updating. (Ord. No. 680; 8-10-2016) 1.01.090 Numbering.

Each ordinance passed by the Governing Body shall be systematically identified by a number assigned to such ordinance pursuant to the systematic numbering system used in the Code of the Town of Mills. The numbering system so adopted shall reflect the sequence of adoption of all the Town of Mills' ordinances from the implementation of such numbering system and shall assign a particular number to only one ordinance. (Ord. No. 680; 8-10-2016)

1.01.101 - Amendment, Repeal, Revision, and Recodification of Code.

- (a) The amendment or repeal of existing provisions of this Code or the insertion of additional provisions in this Code shall be done in the following manner:
 - (i) Ordinances amending existing sections shall designate by section number, the sections which are affected and set out in full the new language of each such section;
 - (ii) Ordinances repealing existing sections shall designate, by section number, the sections which are repealed;
 - (iii)Ordinances adding sections to the Code shall designate where such sections are to be inserted:
 - (iv) The Town Clerk shall maintain a list of all affected ordinances and shall proceed as is consistent with Section 1-1-8 of the Code of the Town of Mills.
- (b) The revision, updating, and recodification of ordinances may be published by title only together with a brief summary of the recodification or revision, in the manner set out in W.S. § 15-1-116, and the actual recodification and revision shall be available to the public at all reasonable hours in the office of the Town Clerk and in a public location in the Town Hall.
- (c) The Governing Body may amend existing schedules, tables or singular costs, expenses, fines or other monies to be collected by resolution, where not contrary to State Statute. When

such amendment has been made by resolution, those parts of the Code affected shall be deleted from the Code and the following shall be inserted as its replacement:

The schedule, tables, rates, fines, or other designation of costs, expenses, fines or other fees have been deleted from this section. The subject addressed in this section has now been amended by resolution. The resolution may be obtained from the Town Clerk's office from the official book of resolutions. (Ord. No. 680; 8-10-2016)

1.01.102 Numbering of Sections, Articles, or Chapters Not Be Given Importance.

The sequence of sections, articles or chapters in the Code shall not be deemed to imply any substantive intent to a particular ordinance. (Ord. No. 680; 8-10-2016)

1.01.103 Validating Act.

All ordinances of the Town of Mills approved, passed, and adopted prior to or simultaneously with the date of 8-10-2016 shall be and are presumptively valid except where repealed. If any ordinance or part of any ordinance is found to be invalid, all other ordinances or parts of ordinances shall be and remain valid. (Ord. No. 680; 8-10-2016)

CHAPTER 1.02 BOUNDARIES

1.02.010 Official Town Boundary.

The official Town boundary of the Town of Mills is established as provided by ordinance and amendments. The legal description is on file with the Town Engineer and the Town Clerk. (Ord. No. 680; 8-10-2016)

1.02.020 Order Creating Municipality.

The Town of Mills was duly incorporated as a Municipal Corporation under the laws of the State of Wyoming on May 10, 1921. (Ord. No. 680; 8-10-2016)

<u>CHAPTER 1.03</u> PENALTIES AND REMEDIES

1.03.010 General Penalties; Remedies Generally; Continuing Violation.

(a) Wherever in this Code or any ordinance, rule or regulation passed by the Governing Body, promulgated by any officer or agency of the Town of Mills under authority vested by law or ordinance, any act prohibited or declared unlawful, or the doing of any act is required or the failure to do any act is declared to be unlawful, whether or not a specific penalty is provided, the violation of any such provision of this Code, or any such ordinance, rule, or regulation, shall constitute a misdemeanor and shall be punishable under this section, or any other section, or amendments.

- (b) Any misdemeanor committed in the Town of Mills, Wyoming, shall be punishable by a fine of no more than seven hundred fifty dollars (\$750.00), to which may be added costs and assessments as set by the Municipal Court, not to exceed the amount allowed by State Statute, for each violation.
- (c) For the following specific misdemeanors committed and formally charged by the filing of a citation or information in the Municipal Court for the Town of Mills, said formal charge filed within one (1) year of a prior conviction in the Municipal Court for the Town of Mills, Wyoming, for the same offense charged, the Court shall have the power to fine or may order imprisonment for a period not to exceed six (6) months, or both, to which may be added Court costs. These specific misdemeanors referenced above for imprisonment for second convictions are: battery, aid in escape, escape, furnishing weapons to prisoners, petty larceny, prostitution, resisting or interference with an officer, injury to property, possession of drugs or paraphernalia, reckless driving, driving while license suspended or revoked.
- (d) The penalty for driving while under the influence of intoxicants shall be in accordance with Wyoming Statutes up to the jurisdictional level conferred upon municipalities including incarceration for a first offense.
- (e) Each day a violation of this Code or any ordinance, rule or regulation continues, shall constitute a separate offense. (Ord. No. 680; 8-10-2016)

1.03.020 Application of Penalty; Parties to a Violation.

Whoever violates any provision of any ordinance of the Town of Mills, whether included in these revised ordinances or ordinances enacted, shall, unless otherwise provided, be liable to a penalty as stated above for each offense. When the provisions prohibit the commission or omission of an act, not only the person actually committing the prohibited act or omitting the act, but also all other persons who commit, attempt to commit, conspire to commit or who aid or abet in the commission of an act declared to be unlawful shall be guilty of the offense described and liable to the penalty set forth. (Ord. No. 680; 8-10-2016)

1.030.30 Action for Penalties or Fines.

All actions brought to recover any penalty or fine shall be brought in corporate name of the Town of Mills. (Ord. No. 680; 8-10-2016)

1.03.040 Disposition of Recoveries.

The recoveries when collected shall be paid into the treasury of the Town of Mills. (Ord. No. 680; 8-10-2016)

CHAPTER 1.04 CORPORATE SEAL

1.04.010 Town Seal Designed and Adopted.

A seal, the impression of which shall be of circular form, bearing the words, "Town of Mills, Wyoming, Est. 1921is adopted as the Town Seal. (Ord. No. 680; 8-10-2016)

1.04.020 Authentication.

A document possessing the seal as set out in Section 1.04.010 of the Code of the Town of Mills shall be prima facie evidence the document is authentic. (Ord. No. 680; 8-10-2016)

1.04.030 Validating Act.

Documents executed by the Town of Mills requiring the seal of the Town and bearing a seal in the form above prescribed are validated and ratified, and approved by the Town of Mills with the same force as if such seal had then been the official seal of the Town of Mills. (Ord. No. 680; 8-10-2016)

1.04.040 Custodian.

The Clerk of the Town of Mills shall be the Custodian of the Corporate Seal and shall affix the seal imprint upon all official documents. (Ord. No. 680; 8-10-2016)

<u>CHAPTER 1.05</u> OFFICIAL NEWSPAPER

1.05.010 Designated.

The Casper Star Tribune and the Casper Journal are hereby appointed, designated and constituted the official newspapers of the Town of Mills. The Governing Body of the Town of Mills shall not be required to make any publication in both of the above newspapers, but may select or designate either of the above newspapers for any publication where publication is required. (Ord. No. 680; 8-10-2016)

<u>CHAPTER 1.06</u> DEPOSITORY DESIGNATED

1.06.010 Depository Designated.

- (a) Any federal or state chartered banks and federally insured brokerage institutions are designated as depositories for the monies of the Town of Mills. The Town Treasurer shall keep and deposit Town monies as designated and directed by the Governing Body by resolution.
- (b) The Governing Body of the Town of Mills may by resolution designate additional or alternate depositories for funds of the Town. (Ord. No. 680; 8-10-2016)

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING the above laws set out above is passed as the Town of Mills Town Code Title 1 General Provisions.

IT IS FURTHER ORDAINED the existing Town of Mills Code Title 1 and all amendments pertaining to Title 1 are repealed.
