## **ORDINANCE 687**

AN ORDINANCE TO AMEND PARTS OF ORDINANCES 276, 390 AND 447, THE MILLS MUNICIPAL CODES 5.12.220, 5.12.070 (e), 5.12.210, 5.12.100 and 5.12.160 TO SET BY RESOLUTION LIQUOR LICENSE FEES AND ESTABLISH REGULATIONS FOR MALT BEVERAGE AND CATERING PERMITS

# REVISED SED FINAL READING

### ARTICLE VI.

#### SPECIAL PERMITS

5.12.220 Twenty-Four Hour Malt Beverage Permit and Catering Permit; Restrictions; Application Procedure; Fees.

- (a) A malt beverage permit authorizing the sale of malt beverages only may be issued by the Town of Mills to any responsible person or organization for sales at a picnic, bazaar, fair, rodeo, special holiday or similar public gathering. No person or organization holding the special permit shall sell any alcoholic liquor other than malt beverages on the premises described on the permit, nor shall any malt beverage be sold or consumed off the premises authorized by the permit.
- (b) A catering permit authorizing the sale of alcoholic and malt beverages may be issued by the Town of Mills to any person holding a retail liquor license authorizing the off- premises sale of both alcoholic and malt beverages, for sales at meetings, conventions, private parties and dinners or at other similar gatherings not capable of being held within the licensee1s licensed premises. No licensee holding a catering permit shall sell or permit consumption of any alcoholic or malt beverage off the premises described in the permit.
- (c) The permits authorized by this section shall be issued for one (1) twenty-four (24) hour period, subject to the schedule of operating hours provided by Section 5.12.260, and shall not authorize sales or consumption on the premises described for more than six (6) thirty six (36) twenty-four (24) hour periods in any one (1) year at the location as set by Wyoming Statue 12-4-502. by the same permit fee.

- (d) The malt beverage permit and the catering permit shall be issued on application to the Town of Mills without public notice or hearing. Any applicant applying for a permit authorized by this section and having licenses premises located within a jurisdiction other than that jurisdiction to which application is made, shall secure the written approval of the licensing authority of that jurisdiction in which the licensed premises are located prior to filing an application for a permit.
- (e) The fee for the malt beverage permit and the catering permit shall be \$\\_25.00\set by resolution annually and be payable to the Town of Mills.
  - (f) Malt Beverage/Alcohol Permit Regulations
  - 1. A catering application and a letter stating the type of event, date, time, etc. must be presented to the Town Council for approval. The Town of Mills Fire and Police Chief may need to approve the application.
  - 2. Underage drinking along with furnishing alcohol to underage persons is strictly prohibited.
  - 3. Access must be provided for fire apparatus and / or other emergency vehicles in case they are needed at all times.
  - 4. Music or public address systems must be kept at reasonable levels so as to not disturb the peace of the community.
  - 5. Immediately after the party is over, the permit holder(s) must ensure that the entire area is which the party was held is free of litter, garbage and other party items. The area must be returned to its original state.
  - 6. Fire hydrants shall not be blocked or obstructed.
  - 7. Maximum of 36 permits will be issued per any location per year.
  - 8. The event may start 9:00 AM and must end by 10:00 PM or as otherwise set by Town Council.
  - 9. Permit holder(s) will erect suitable barricades or temporary fences with only 1 (one) entrance and will remove them at the conclusion of the event.
  - 10. No glass bottles or containers shall be allowed outside.
  - 11.21 and over must wear wrist bands.

- 12. Permits will be logged to show the dates and times of events held.
- 13. Police and fire departments shall be authorized to shut down and clear any event for reasons of public safety, disturbances of peace or violations of applicable laws, or other just cause.
- 14. Any violation of these regulations or other applicable laws will result in the denial of any future permits to the holder(s) of permits resulting in violations.
- 15. The Mills Town Council shall be authorized to impose any other reasonable regulations, conditions or restrictions as required by the event.

# ARTICLE III RETAIL LIQUOR LICENSES

<u>Section 1.</u> That part of Ordinance 349 appearing in the Mills Municipal Code as Section 5.12.070(e) is hereby amended to read as follows:

The annual fee assessed for a retail liquor license shall be One Thousand Two Hundred and No/100 Dollars (1,200.00) set by Resolution from time to time by Town Council and payable annually in advance of original issue and each renewal.

Section 2. That part of Ordinance 276 appearing in the Mills Municipal Code as Section 5.12.210 is hereby amended to read as follows:

The annual fee assessed for a restaurant liquor license shall be One Thousand Two Hundred and No/100 Dollars (\$1,200.00) set by Resolution from time to time by Town Council and payable annually in advance of original issue and each renewal.

# ARTICLE IV SPECIAL CLUB LICENSES

# **SECTION 1**

Section 5.12.100 is hereby amended as follows:

- 5.12.100 Sales by clubs License fees Petition License restrictions.
- (a) Bona fide clubs as defined by subsection (c) of Section 5.12.101 may be licensed by the town under a limited retail liquor license for which the license shall pay a license fee of seven hundred and fifty dollars as set by Resolution annually from time by Town Council in advance.

#### **ARTICLE V**

Section 5.12.160 is hereby amended as follows:

5.12.160 Annual Fee.

The annual fee for a resort liquor license is three thousand dollars. shall be set by Resolution from time to time by the Town Council and be paid to the Town of Mills.

This amended ordinance shall be in full force and effect from and after passage on three readings and publication. posting as permitted by law.

IT IS FURTHER ORDAINED: That upon passage and execution of this Ordinance it shall be filed with the office of the Natrona County Clerk.
