

ORDINANCE NO. 69

AN ORDINANCE VACATING CERTAIN PARTS OF STREETS, AVENUES AND ALLEYS IN THE TOWN OF MILLS,
WYOMING Page 1

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MILLS:

Section 1. That the parts of streets, avenues and alleys below described, as same are shown on the recorded plats of the Town of Mills, the SECOND ADDITION TO MILLS ADDITION, respectively, that is:

1. That part of Wasatch Avenue which lies southeasterly of a line produced across Wasatch Avenue from the most westerly corner of Lot 5 in Block 8 at right angles to the southwesterly boundary line of said Lot 5;
2. That part of the unnamed street, avenue or alley abutting and running along the southeasterly boundary line of Lot 8 in Block 8, which lies southwesterly of a line produced across said unnamed street, avenue or alley from the most easterly corner of said Lot 8 at right angles to the southeasterly boundary line of said Lot 8;
3. That part of First Street which lies southwesterly of a line produced across said First Street from the most easterly corner of Lot 16 in Block 18 at right angles to the southeasterly boundary line of said Lot 16;
4. That part of River Drive which lies southeasterly of a line produced south $11^{\circ} 44' 30''$ west across said River Drive from the jog in the southwesterly boundary line of Lot 2 in Block 55 which is 36 feet distant from the most westerly corner of said Lot 2;
5. That part of Platte Avenue which lies southeasterly of a line produced across said Platte Avenue south $43^{\circ} 45'$ west from a point in the southwesterly boundary line of Lot 15 in Block 19, which is 76.32 feet distant from the most southerly corner of Lot 16 in Block 19;
6. That part of Midwest Avenue which lies southeasterly of a line produced across said Midwest Avenue ~~of~~ South ~~at~~ $59^{\circ} 17'$ west from a point in the southwesterly boundary line of Lot 16 in Block 18, which is 29.50 feet distant from the most southerly corner of said Lot 16;
7. That part of the alley in Block 19 which lies southeasterly of a line produced from the most westerly corner of Lot 2 in Block 19 ~~to~~ to the most northerly corner of Lot 15 in Block 19;

be and the same are hereby vacated and forever closed to public use.

Section 2: That the parts of streets, avenues and alleys described in paragraphs numbered 1 and 2 in Section 1 of this ordinance and by said Section 1 of this ordinance vacated, shall hereafter constitute and form a part of TRACT A in the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 7, Township 33 North, Range 79 West of the 6th P.M. so that said TRACT A will consist of Lots 5, 6, 7 and 8 in Block 8 as shown and designated on the above mentioned plats of the TOWN OF MILLS, SECOND ADDITION TO MILLS ADDITION and THIRD ADDITION TO MILLS ADDITION respectively, and the parts of streets, avenues and alleys vacated as aforesaid, and described in said paragraphs numbered 1 and 2, Section 1 of this ordinance.

Section 3: That the parts of streets, avenues and alleys described in paragraphs numbered 3, 4, 5, 6 and 7, Section 1 of this ordinance and by said Section 1 of this ordinance vacated, shall hereafter constitute and form a part of Tract B in the NW $\frac{1}{4}$ SE $\frac{1}{4}$ and NE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 7, Township 33 North, Range 79 West of the 6th P.M., so that TRACT B will consist of Lot 16 in Block 18, Lots 1, 2, 15 and 16 in Block 19, Lots 1 and 2 in Block 55, as shown and designated on the above mentioned plats of the TOWN OF MILLS, SECOND ADDITION TO MILLS ADDITION and the THIRD ADDITION TO MILLS ADDITION, respectively, and the parts of streets, avenues and alleys vacated as aforesaid, and described in said paragraphs numbered 3, 4, 5, 6, and 7 of Section 1 of this Ordinance.

Section 4: That an emergency being deemed to exist, this ordinance shall take effect and be in force and effect from and after its passage and approval.
