ORDINANCE NO. 693

AN ORDINANCE TO AMEND SECTION 2.24.090 OF THE MILLS MUNICIPAL CODE TO SPECIFY A DATE CERTAIN FOR THE MUNICIPAL COURT TO SETTLE ITS ACCOUNTS AND MAKE PAYMENT TO THE TOWN TREASURER.

WHEREAS; the Town of Mills is required to specify a date upon which the municipal court shall settle with the treasurer and pay all money into the treasury for the benefit of the funds to which the monies belong; and

WHEREAS; this amendment is necessary to ensure compliance with W.S. §15-1-126.

NOW THEREFORE BE IT ORDAINED SECTION 2.24.090 OF THE MILLS MUNICIPAL CODE IS HEREBY AMENDED AS FOLLOWS:

2.24.090 Payment of fines to town treasurer. The municipal judge shall remit to the town treasurer all moneys accrued from fines collected and forfeited, recognizance, bonds, or other costs and penalties collected by virtue of his office, such remittance to be made ~~regularly, but~~ not less than once monthly, **due on or before the 30th day of the next month. If the 30th day of the month falls on Sunday, or a legal holiday, the payment shall be made on the next proceeding business day.**




