ORDINANCE NO. 695

AN ORDINANCE AMENDING ORDINANCE 2.16.020 OF THE MILLS MUNICIPAL CODE PERTAINING TO SALARIES OF COUNCIL MEMBERS

WHEREAS W.S. 15-22-103 authorizes the Town to fix the salaries for the mayor and council members, and;

WHEREAS the amount of salary fixed by Ordinance 695 shall not change during the term for which any person serving as council member was elected or appointed.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING THAT SECTION 2.16.020 OF THE TOWN OF MILLS MUNICIPAL CODE IS HEREBY AMENDED AS FOLLOWS:

SECTION 1: SALARY OF COUNCILMEN

2.16.020 Councilmen. The salary for each council person shall be **one hundred and** fifty dollars (\$150.00) for actual attendance at each regular or special meeting of the Council.

SECTION 2: EFFECTIVE DATE

This Ordinance shall be in full force and effective ten (10) days following its passage and approval on third and final reading: However, the provisions of this Ordinance shall not be given retroactive effect with regard to any council member duly elected or appointed and serving at the time of the passage of this Ordinance.

PASSED on 2nd reading the 7th day of December, 2016.

PASSED, APPROVED, AND ADOPTED on the 3rd and final reading on the 21^{sd} day of December, 2016.
