## ORDINANCE No. 698

### AN ORDINANCE ADOPTING AND APPROVING A FRANCHISE AGREEMENT WITH BRESNAN COMMUNICATIONS, LLC

WHEREAS, the Town of Mills is a duly authorized municipal corporation under the laws of the State of Wyoming;

WHEREAS, the Town of Mills has the authority under Wyoming State Statutes to enter into agreements and grant franchises;

WHEREAS, the Town of Mills has negotiated with Bresnan Communications, LLC, locally known as CHARTER COMMUNICATIONS, hereafter referred to as Bresnan;

WHEREAS, the Town of Mills has reached an agreement with Bresnan which is beneficial to the citizens of Mills and provides revenue to Mills;

WHEREAS, the Town of Mills has reduced this agreement to a writing and the writing is referenced as FRANCHISE AGREEMENT and will be attached to this ordinance by the Town Clerk and is made part of this ordinance; and,

WHEREAS, the Town of Mills has reviewed and considered the grant of this franchise agreement and its impact upon its citizens and the revenues of the Town of Mills and has acted as shown below.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING: the FRANCHISE AGREEMENT referenced above and attached to this ordinance is hereby adopted as the franchise agreement between Bresnan and the Town of Mills.


BE IT FURTHER ORDAINED the Mayor is authorized to sign the FRANCHISE AGREEMENT.

BE IT FURTHER ORDAINED the Town Clerk shall enroll this ordinance and place on file the Franchise Agreement and the Town Treasurer shall monitor and certify funds are received pursuant to the Franchise Agreement terms for compensation to the Town of Mills.




