

**ORDINANCE NO. 705**

Chapter 2.04

**AN ORDINANCE AMENDING SECTION 2.04.010 OF THE TOWN OF MILLS MUNICIPAL CODE PERTAINING TO TIME AND PLACE OF COUNCIL MEETINGS**

WHEREAS, the Town Council wishes to change the time of its regular meetings, and provide for additional meetings and work sessions, and;

WHEREAS, it is necessary to provide a procedure to hold the regular meetings of the Mills Town Council on an alternate date in cases where the Mayor or other council members cannot attend the regular meetings.

NOW THEREFORE, BE IT ORDAINED, BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING, section 2.04.010 of the Mills Municipal Code is hereby amended as follows:

2.04.010 Time and place of meetings.

- (A) Regular meetings of the Town Council shall be held on the second and fourth Wednesday of each month. Regular meetings shall commence at 7:00 PM and be held at the Council Chambers at 704 Fourth Street, or at any other place designated according to law.
- (B) In the event the Mayor or a quorum of council members shall be unable to attend the regular meetings of the Town Council due to illness, scheduling conflicts, or any other reason, the Council may elect to hold its regular meeting at another date and time as determined by the Council. In the event any regular meeting of the Town Council is rescheduled as provided herein, the Town Clerk shall cause a notice of the date and time of such meeting to be posted in the Towns three public places within 72 hours before the date of the rescheduled meeting.
- (C) In the event the Council desires to hold any additional or special meetings, the Council shall specify the date, time and place of any such special meeting at the regularly scheduled Council meeting of each month.
- (D) The Town Council will hold work sessions commencing at 3:00 PM on the Tuesday before the second Wednesday of each month. Work sessions shall be held at the council meeting room at 704 Fourth Street. Work sessions shall be for the purpose of discussion, deliberation and presentation of information to the Council, however no actual votes shall be taken upon any motion, proposal, resolution, regulation, rule, order or ordinance at any work session. Work sessions shall be open to the public. (Ord. 570, 2011, Ord. 517, 2005, Ord. 216, 1973, Ord. 166, 1966)
