

ORDINANCE NUMBER SEVENTY-EIGHT-B

AN ORDINANCE TO AMEND AND RE-ENACT SECTION TEN OF ORDINANCE NUMBER SEVENTY-EIGHT, WHICH IS AN ORDINANCE PROVIDING FOR THE LICENSING AND REGULATION OF TRAILER COACH PARKS AND CABIN CAMPS WITHIN THE TOWN OF MILLS, WHICH SECTION TEN PROVIDES FOR THE WATER SUPPLY AND RATE AT WHICH WATER SHALL BE FURNISHED TO SAID PARKS AND CAMPS.

BE IT ORDAINED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF MILLS:

SECTION 1. THAT SECTION TEN OF ORDINANCE NUMBER SEVENTY-EIGHT BE AMENDED AND RE-ENACTED TO READ AS FOLLOWS:

SECTION 10. WATER SUPPLY AND RATE AT WHICH FURNISHED. That an adequate supply of pure water from the municipal water system, shall be supplied for drinking and domestic purposes to meet the requirements of all trailer coach parks. Such water shall be obtained from faucets only and no common drinking cups shall be permitted. Water for such purposes and for all other requirements of each trailer coach park shall be measured through one common meter of the type designated by the Town Water Commissioner and the rate charged for such water shall be the Industrial Rate approved by the Wyoming Public Service Commission at Cheyenne:--

Minimum: \$3.00 for 3,000 gallons or less per month

Rate: 20¢ per 1,000 gallons above the minimum

That the bill for all water consumed by each trailer park shall be charged to the owner or proprietor of the said park and shall be collectable in the same manner as other water bills as established by ordinance of the Town Council.

SECTION 2. THAT THIS ORDINANCE SHALL TAKE EFFECT AND BECOME IN FORCE AFTER ITS BEING POSTED UP FOR A PERIOD OF TEN DAYS, AS REQUIRED BY LAW.
