

ORDINANCE NUMBER SEVENTY-NINE

THE ANNUAL APPROPRIATION ORDINANCE FOR THE NEXT FISCAL YEAR
(BEGINNING MARCH 1, 1949, AND ENDING FEBRUARY 28, 1950)

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MILLS, WYOMING:

SECTION 1.-- UNEXPENDED MONEYS TO REVERT TO GENERAL FUND. That all moneys hereby appropriated, but remaining unexpended at the end of the fiscal year for which this appropriation is made, shall revert to the general fund of the th~~e~~ Town and shall be subject to subsequent appropriation.

SECTION 2.-- STATED ESTIMATE OF AVAILABLE ASSETS. That the present and anticipated assets of the town fo Mills, from which the herein provided appropriated moneys are to be paid out in the course of the fiscal year, are hereby stated to be approximately as follows:
