

ORDINANCE NUMBER EIGHTY-FIVE

AN ORDINANCE ESTABLISHING THE AMOUNT OF THE MUNICIPAL TAX FOR THE TOWN OF MILLS, WYOMING, FOR THE YEAR OF 1950.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MILLS, WYOMING:

SECTION 1.-- TAX SET IN ACCORDANCE WITH ESTABLISHED PRECEDENT AND WITH WYOMING STATE LAW.

That in accordance with precedent established by Ordinance of the Town Council of the town of Mills, and in compliance with Section 115-1001 of the revised statutes of the state of Wyoming (1931) and in order to meet the current expenses of the town of Mills, there shall be levied upon all property, real, personal, and mixed, within the corporate limits of the said town, excluding only that property which is by Wyoming law exempt from taxation, a general tax for the year of 1950, of Eight (8) mills on each dollar of assessed valuation; and that the Town Clerk is hereby authorized and directed to certify to the County Clerk of Natrona County, Wyoming, that the above specified assessment is legal and correct and in accordance with the decision of the Town Council of the Town of Mills.

SECTION 2.-- THAT THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FORCE FROM AND AFTER ITS POSTING UP FOR A PERIOD OF TEN DAYS AS REQUIRED BY LAW.

RESOLUTION TO AUTHORIZE SIGNING OF A CONTRACT WITH THE UNITED STATES DEPARTMENT OF THE INTERIOR BUREAU OF RECLAMATION FOR THE ACQUISITION BY THE TOWN OF MILLS, WYOMING, OF TITLE TO AND OWNERSHIP OF THE SANITARY SEWER LINE AND SEWAGE DISPOSAL PLANT WHICH THE SAID BUREAU OF RECLAMATION DOES OPERATE AND MAINTAIN WITHIN THE CORPORATE LIMITS OF THE SAID TOWN, AND ~~AGREEMENT~~ AGREEING, IN CONSIDERATION OF RECEIPT OF THE SAID TITLE AND OWNERSHIP, TO FURNISH SANITARY SEWER SERVICE FREE OF CHARGE FOR A PERIOD OF FIFTEEN YEARS, TO THE OCCUPANTS OF THOSE CERTAIN DWELLING HOUSES, OFFICES AND/OR OTHER INSTALLATIONS OWNED AND MAINTAINED BY THE RECLAMATION BUREAU FOR THE PERFORMANCE OF ITS FUNCTIONS AND FOR THE ACCOMMODATION OF ITS EMPLOYEES.

Upon a motion made by Councilman Edmund Miller, seconded by Councilman Ed. B. Edwards, fully discussed and considered, regularly put and unanimously carried, the following resolution was adopted:

THAT WHEREAS the United States Department of the Interior Bureau of Reclamation owns, maintains and operates a sanitary sewer line and sewage disposal plant, the former situated partially within the corporate boundary line of the town of Mills, Wyoming, and the latter wholly so situated; the corporate boundary of the said town of Mills enclosing the: $S\frac{1}{2}$ NW $\frac{1}{4}$, N $\frac{1}{2}$ SW $\frac{1}{4}$, NW $\frac{1}{4}$ SW $\frac{1}{4}$, SW $\frac{1}{4}$ SW $\frac{1}{4}$ of section seven (7) township thirty-three (33) north of range seventy-nine (79) west of the sixth (6th) principal meridian, such location being within Natrona county, in the state of Wyoming; the said sewer line, together with manholes and other devices used in the operation and/or maintenance of same, being situated beneath, across and within the boundary lines of portions of Pendell and Wyoming boulevards, Morgan avenue and Second street, all within the platted district of the aforesaid town of Mills, and extending across and beneath lands within such corporate boundary as aforesaid but not within the platted portion of such town, from the intersection of the said Morgan avenue with the said Second street, the southwesterly boundary of which intersection is also the boundary of the said platted district, in a generally southwesterly direction for a distance of approximately one hundred fifty (150) feet, to a point adjacent to the Platte river; and the said sewage disposal plant being situate at the terminus of the aforesaid sewer line at the point adjacent to the Platte river as hereinabove described; and

WHEREAS the said sanitary sewer line and sewage disposal plant have heretofore been the subject of correspondence between the said town of Mills and the said Bureau of Reclamation, relative to the acquisition by the said town of title to and ownership of the said facilities, such correspondence authorized by, and pursuant to, resolution of the Town Council (under date of February First, 1930) to the effect that such acquisition of the said facilities would be of great value and advantage to the said town; and

WHEREAS the aforesaid Bureau of Reclamation has offered to convey title to and ownership of such sewer line and sewage disposal plant as aforesaid to the said town of Mills in exchange for an agreement by the said town to furnish sanitary sewer service free of charge for a period of time to the occupants of those dwellings, offices and other establishments presently owned and maintained by the said Reclamation Bureau for the performance of its functions and for the accommodation of its employees, immediately adjacent to the said town; and

WHEREAS ownership of the said sewer line by the said town would be of very considerable advantage to those householders within the said town who have attached private sewer lines to ~~the~~ such main sewer line, but of no immediate advantage to other residents of the said town (though all residents may be eventually benefitted by extension of such sewer main); and

WHEREAS the approximate life of this type of sewer is twenty years; and

WHEREAS the said sewer main having been constructed approximately five years ago, cannot certainly be expected to remain in operation, without very extensive repairs and replacements, more than an additional fifteen years;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF MILLS, WYOMING:

That the Mayor and Town Clerk of the town of Mills, Wyoming, are hereby authorized and directed to receive for the said town of Mills, from the United States Department of the Interior Bureau of Reclamation, title to the sanitary sewer line and sewage disposal plant, as hereinbefore more particularly described, and in consideration of the receipt of such title, to sign a contract with the said Bureau of Reclamation, in which the said town of Mills shall be bound to furnish sanitary sewer service free of charge for a period of fifteen years to occupants of those dwelling houses, offices and other installations presently owned and maintained by the said Bureau of Reclamation for the performance of its functions and for the accommodation of its employees, immediately adjacent to the town of Mills;

RESOLUTION TO AUTHORISE SIGNING OF A CONTRACT WITH THE UNITED STATES DEPARTMENT OF THE INTERIOR BUREAU OF RECLAMATION FOR THE ACQUISITION BY THE TOWN OF MILLS, WYOMING, OF TITLE TO AND OWNERSHIP OF THE SANITARY SEWER LINE AND SEWAGE DISPOSAL PLANT WHICH THE SAID BUREAU OF RECLAMATION TENDS OPERATE AND MAINTAIN, ETC., -- Page 3

Provided that such contract may provide for the exertion of all reasonable effort on the part of the said town of Mills, to maintain the said sewer line and sewage disposal plant in continuous ~~operation~~ and uninterrupted operation;

Provided further that such contract shall not provide for a continuation of such sewer service as aforesaid free of charge, after fifteen years from date of such contract; nor shall such contract provide for the furnishing of such service by the said town free of charge for any building or other installation, owned by the said Bureau of Reclamation, other than those presently existing and at present serviced by the sewer line and disposal plant herein described, unless such other installation shall be in the nature of a replacement to an establishment now existing and so serviced.
