ORDINANCE NUMBER EIGHTY-EIGHT

PROVIDING FOR AN AMENDED SALARY RATE FOR THE MAYOR, TOWN CLERK, TREASURER, MARSHAL, POLICE INSTITUTE, WATER COMMISSIONER, AND STREET COMMISSIONER OF THE TOWN OF MILLS: AMENDING ORDINANCE X FIFTY-TWO AS TO SUB-SECTION ONE OF SECTION ONE OF SECTION FIVE THEREOF, SUB-SECTION TWO OF SECTION TWO OF SECTION SEVEN THEREOF, SUB-SECTION TWO OF SECTION ELEVEN THEREOF, SUB-SECTION ONE OF SECTION ELEVEN THEREOF, AND SUB-SECTION ONE OF SECTION ELEVEN THEREOF, AND SECTION ONE OF ORDINANCE FIFTY-TWO B, IN SO FAR AS SAID SECTION AND SUB-SECTIONS RELATE TO THE SALARY OF THE ABOVE HAMED OFFICIALS, AND ALL OTHER ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF MILLS, WYOMING:

SECTION 1. -- MAYOR'S SALARY. That the Mayor of the town of Mills shall receive payment for his services to the said Town at the rate of Eight (\$8.00) dollars for each and every meeting of the Town Council attended by such Mayor, except that the Mayor shall not receive more than One Hundred Fifty (\$150.00) dollars in any one fiscal year.

SECTION 2.--TOWN TREASURER'S SALARY. That the Town Treasurer of the town of Mills shall receive, a salary of Three Hundred Sixty (\$360.00 dollars per annum to be paid in twelve equal installments of Thirty (\$30.00) dollars each.

SECTION 3. -- TOWN CLERK'S SALARY. That the Town Clerk of the town of Mills shall receive a salary of Three Hundred (\$300.00) dollars per annum, to be paid in twelve equal monthly installments of Twenty-five (\$25.00) dollars each.

SECTION 5. -- WATER COMMISSIONER'S SALARY. That the Water Commissioner of the town of Mills shall receive a salary of Two Thousand Three Hundred Seventy (\$2370.00) per annum, to be paid in twelve equal monthly installments of One Hundred Ninety Seven (\$197.50) dollars and Fifty Cents each.

SECTION 6I -- SALARY OF POLICE JUSTICE. That the Police Justice of the town of Mills shall receive a salary of Two Hundred Forty (\$240.00) dollars per annum, to be paid in twelve annual monthly installments of Twenty (\$20.00) dollars each.

SECTION 7. -- SALARY OF STREET COMMISSIONER. That the Street commissioner of the town of Mills shall receive a salary of Eight Hundred Ten (\$810.00) dollars per annum, to be paid in twelve equal monthly installments of Sixty Seven (\$67.50)dollars and Fifty cents each.

SECTION 3. — EFFECTIVE WITH BEGINNING OF SUBSEQUENT TERMS OF OFFICE. That the salaries provided in the foregoing sections of this ordinance shall be effective upon the beginning of the official term of all those officers succeeding present incumbents in the offices affected by the provisions of this ordinance.

SECTION 9.—SALARIES PAID OUT OF GENERAL FUND. That the salaries of officials of the town of Mills herein provided shall be paid out of the general fund of the said town, upon proper appropriation of such funds for such purposes, in the same manner as that in which other claims against the town of Mills are paid.

SECTION 10.— REPEAL OF CONFLICTING SECTIONS AND SUB-SECTIONS OF ORDINANCES IN CONFLICT. That Urdinance Number Fifty-two is hereby amended as to Sub-section one of Section Four thereof, Sub-section One of Section Five thereof, Sub-section Two of Section Six thereof, Sub-section, Two of Section Seven thereof, Sub-section Two of Section Eight thereof, and Sub-section One of Section Eleven thereof; and Section One of Ordinance Fifty-two B is hereby likewise amended, insofar as the above named Section and Sub-sections relate to the salaries of any of the above named officials, which said salaries shall be as herein established, notwithstanding the provisions of any of the sub-sections of sections herein amended; and all other ordinances and parts of ordinances in conflict herewith are hereby repealed.

SECTION 11. -- OTHER PORTIONS OF CEDIMATOES NOT AFFECTED HEREBY. That nothing herein contained shall be construed as altering or affecting any part of the Ordinances herein appended, except as specifically stated herein with regard to salarios.

SECTION 12. -- THAT THIS CROTHANCE SHALL TAKE EFFECT AND BECOME IN FORCE UPON ITS ENACTMENT X AND BEXING POSTED UP FOR A PERIOD OF NEW DAYS AS REQUIRED BY LAW.
