ORDINANCE NUMBER EIGHTY-EIGHT-B

PROVIDING FOR THE ADJUSTMENT OF THE SALARY OF THE FIRE CHIEF AND OF THE TOWN TREASURER, RESPECTIVELY, OF THE TOWN OF MILLS, WYOMING: AND REPEALING SECTION TWO OF ORDINANCE NUMBER EIGHTY-EIGHT, WHICH ORDINANCE ESTABLISHES THE SALARIES OF TOWN OFFICIALS GENERALLY; AND SECTION ONE OF ORDINANCE EIGHTY-EIGHT-A, WHICH ESTABLISHES THE SALARY OF FIRE CHIEF.

BE IT ORDAINED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF MILLS, WYOMING:

SECTION(1) SALARY OF FIRE CHIEF. That the Chief of the Fire Department of the town of Mills, Wyoming shall receive a salary of Four Hundred Twenty (\$420.00) dollars per annum, to be paid in twelve equal monthly installments of Thirty-five (\$35.00) dollars each; such salary to be irrespective of and in addition to any renumeration received by the said Fire Chief under the provisions of Sections Seven and Sixteen of Ordinance Number Eighty-seven.

SECTION 2. SALARY OF TOWN TREASURER: That the Town Treasurer of the aforesaid town of Mills shall receive a salary of Five Hundred Forty (\$540.00) dollars per annum, to be paid in twelve equal monthly installments of Forty-five (\$45.00) dollars each.

SECTION 3. SALARIES PAID OUT OF GENERAL FUND. That the salaries herein provided shall be paid out of the general fund of the town of Mills, upon proper appropriation of such funds for such purposes, in the same manner as that in which other claims against the town of Mills are paid.

SECTION 4. REPEALING SECTION TWO OF ORDINANCE NUMBER EIGHTY-EIGHT, AND SECTION ONE OF ORDINANCE EIGHTY-EIGHT-A.

That Section Two of Ordinance Number Eighty-Eight, and Section One of Ordinance Number Eighty-Eight-A, which sections provide and establish salary rates for Town Treasurer and Fire Chief, respectively, are hereby repealed.

SECTION 5. EFFECTIVE That this ordinance shall take effect and become in force as a legal ordinance of the Town of Mills, Wyoming upon its being enacted by the Town Council and posting up for a period of ten days, as required by law.
