

ORDINANCE NUMBER EIGHTY-NINE -- A

AMENDING ORDINANCE NUMBER EIGHTY-NINE TO AUTHORIZE THE BUILDING INSPECTOR OF THE TOWN OF MILLS, WYOMING, TO PERFORM THE DUTIES AND TO POSSESS ALL THE POWERS AND AUTHORITY OF THE ELECTRICAL INSPECTOR OF THE SAID TOWN, IN ANY CASE OF ABSENCE OF THE SAID ELECTRICAL INSPECTOR FROM ACTIVE DUTY, OR WHEN NO SUCH OFFICER HAS BEEN DULY APPOINTED.

BE IT ORDAINED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF MILLS, WYOMING:

SECTION 1.-- AMENDING CHAPTER TWO OF ORDINANCE NUMBER EIGHTY-NINE TO THE EXTENT THAT THE FOLLOWING PARAGRAPH SHALL BE ADDED TO AND INCLUDED IN SECTION 2-101 OF THE SAID CHAPTER.

(c) Building Inspector Authorized. That during the absence of the Electrical Inspector of the town of Mills, Wyoming, or in any case of incapacity of such officer to perform his duties as provided by ordinance, or in the event that no such officer has been duly appointed and qualified, it shall be the duty of the Building Inspector of the said Town, and the said Building Inspector is hereby authorized and directed to perform the duties of the aforesaid Electrical Inspector, and the said Acting Electrical Inspector shall have and possess all of the official powers of the regular Electrical Inspector, as provided by this and other ordinances of the said town of Mills, and shall have full authority to act under such power. Provided that the said powers and authority herein provided to be vested in the Building Inspector, shall lapse automatically, upon the qualification for office of a person duly appointed to fill the office of Electrical Inspector, or in the case of absence or incapacity of such officer, upon his return to active duty.

SECTION 2.-- OTHER SECTIONS TO REMAIN. That except as otherwise provided in other ordinances of the town of Mills, all remaining sections and chapters of the aforesaid Ordinance number Eighty-nine shall remain as presently existing and in full effect, unaffected by this amendment; and those sections having to do with penalty, constitutionality, etc., shall be applicable hereto in the same manner as such sections apply to the original body of Ordinance Number Eighty-nine itself.
