ORDINANCE NO. 99-A

AN ORDINANCE TO AMEND ORDINANCE NO: 99, WHICH IS REFERRED TO AS THE SEWER ORDINANCE, BY ADDING THERETO SECTION 11, WHICH HAS PREVIOUSLY BEEN REPEALED: AND PROVIDING FOR AN EMERGENCY.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWN OF MILLS,
WYOMING:

SECTION 1. That Section 11 of Ordinance NO. 99 be as follows:

SECTION 11. That from and after the effective date of this Ordinance, it shall be unlawful for any person to have a drain emptying into the sewer system of this Town that collects rain water, melting snow and other moisture that collects outside of, on top of, and around buildings. This exclusion includes, but is not confined to, drains from roofs of buildings, and drains designed to catch and carry off rain water and water from melting snow.

SECTION 2. Whereas an emergency exists and such is declared to be the case, this ordinance shall take effect and be in force from and after its passage by the Town Council and proclaimed by the Mayor of the Town of Mills, Wyoming.

Thereupon Councilman Maurer introduced and there was read in full the following Ordinance, to-wit:

ORDINANCE NO. 100

AN ORDINANCE AUTHORIZING THE TOWN OF MILLS, WYOMING, TO ISSUE SEWERAGE SYSTEM REVENUE BONDS IN THE PRINCIPAL AMOUNT OF \$145,000; PROVIDING FOR THE PAYMENT OF SUCH BONDS AND THE INTEREST THEREON; PROVIDING THAT SEWER RATES AND CHARGES SHALL BE ESTABLISHED WHICH SHALL BE SUFFICIENT TO PAY MAINTENANCE AND OPERATION EXPENSES OF THE SEWERAGE SYSTEM OF SAID TOWN, THE PRINCIPAL OF AND INTEREST ON SAID BONDS, AND BOND AND DEPRECIATION RESERVES; PROVIDING OTHER DETAILS IN CONNECTION WITH THE ISSUANCE OF SAID BONDS; AND DECLARING AN EMERGENCY.
