RESOLUTION NO. 2020-18

A RESOLUTION TEMPORARILY MODIFYING THE "SERVING AREA" OF CERTAIN LIQUOR LICENSE HOLDERS

WITNESSETH

WHEREAS, on March 13, 2020, the President of the United States, Donald J. Trump, proclaimed a National Emergency Concerning the Novel Coronavirus Disease (COVID 19) Outbreak; and

WHEREAS, on March 13, 2020, the Governor of the State of Wyoming, Mark Gordon, declared a state of emergency to exist in Wyoming due to the Novel Coronavirus Disease (COVID 19) Outbreak; and

WHEREAS, the Chief Health Officer for the State of Wyoming has ordered the health officer for the counties of Wyoming to impose restrictions upon the operations of businesses and livelihoods in the hopes of slowing the outbreak of COVID 19 in Wyoming; and

WHEREAS, some of these restrictions have involved the closing of restaurant inside seating; and

WHEREAS, the State of Wyoming has modified its existing orders such that restaurants which are engaging in "curb side" delivery of food for pickup have been given an exemption from the liquor laws of the State of Wyoming on a temporary basis such that they may also deliver alcohol to said customers curb side; and

WHEREAS the municipalities that issue liquor licenses also have the ability to define the serving areas for the same; and

WHEREAS, the State of Wyoming has since approved a variance for Natrona County, Wyoming allowing restaurants to resume operations provided that the seat their customers outside and otherwise comply with the provisions of that order, said order being Public Health Order 20-4; and

WHEREAS several establishments in the Town of Mills that have liquor licenses also serve food and serving both are integral parts of their operations.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE TOWN OF MILLS, hereby defines the "serving area" for liquor licenses operating with in the Town of Mills which also may serve food out of doors under those emergency orders issued by the State of Wyoming and as modified by the health officer of Natrona County to include the parking lots and outdoor areas of those establishments. This order shall remain in effect as long as the Order of the Natrona County Health Officer, Public Health Order 20-4, Variance Order To Modify Restrictions Under Statewide Order #1, shall remain in effect. It is further provided that the provisions of this Resolution are temporary in nature and that serving areas shall revert to their prior descriptions upon the expiration of Public Health Order 20-4 or the cessation of the Public Health Orders issued by Natrona County or the State of Wyoming which pertain to the Novel Coronavirus (COVID-19) Outbreak.
