**Open Discussion:**


**Paulette Moore**

Paulette Moore addressed the council about her address on 479 Badger. She had a couple of issues that she wanted the town to take care of. First is the speeding on Badger. We need to have someone patrol the area and ticket people. They are speeding and she feels it is unsafe and that somebody will get hurt. Chief Preciado stated that he will get somebody over there to watch the area and check for speeders. She wanted to know if we have signs posted of the speed limit. Her next issue is when we changed the street name nobody can find her house. On Google Maps it shows her house in a different location than it is now. This is the 3<sup>rd</sup> time she has come in to talk about this. She is afraid that if an emergency happens they will not be able to find her. Town Planner Scott Radden stated that he has turned everything in to our local office and they have it right. We have no control when Google Maps gets the update. Scott stated that he will look into it. The Chief of Police stated he wanted to get her phone number so we can look into it further. Paulette stated that her house is on the corner of Freden and Badger but the sign says Coyote. Councilman McCarthy looked up her house on Google and says she can change the location of her house that it is showing on Google Maps. After the meeting Councilman McCarthy will show her how to do this.

**Art Boatright:**

Art is doing the concrete for the Cedar Springs Wind Farm Project. He has some trailers that people are living in on his property. He did not know that he had to have a special use permit. It is his fault and he will do what it takes to make it right. He has about 5 to 9 trailers and they are all self-contained. They are just parked on his property to watch the site and since they have to get going early in the morning they are there to set up early and then get going. Mayor Coleman stated that he will have him get with Scott and Pat the Town Attorney to see what has to be done. But for right now he is ok and Council will look into Title 17 for man camps.
