

REGULAR TOWN HALL MEETING

February 13th, 2019

Meeting called to order by Mayor Coleman at 7:00PM

Approval of the meeting minutes from January 23rd, 2019.

<u>Public Hearing</u>: The Town is Applying for A Grant from the Wyoming Business Council, Under the Business Ready Community Grant and Loan Program for the Infrastructure Development and River Bank Stabilization for the River Front Property.

Open Discussion:

Lucile Sutherland:

Lucile wanted to know if there is any new news on USA Trucking. Mayor Coleman stated that the Town is trying work things out with the County and USA Trucking on what the residents' concerns are and have them be addressed. Mayor stated that we plan to have someone there on the Feb 19th, 2019 meeting for the County. Lucile stated that they will have a lot of people there too and was wondering if we have heard anything about MSDS Sheets. This is about the chemicals they have. Mayor stated that our Fire Department has some of the information about the chemicals on hand. But the County would have some of that information as well. Mayor stated that he has heard from the residents and they are concerned with how the chemicals are stored, the noise at night and on weekends and the dust. That is what we are trying to work with them on. They are trying to do an Industrial zone change of nearly 100 acres on our border of the town which is not acceptable. Lucile stated that she and others are concerned with the water run off that comes down Abbott Street and 6th Street. Running water

and mud everywhere. Mayor stated to Lucile that the Town has had little to no say in the involvement of this process. The Mayor stated that number one we do not think that the concerns of our residents have been address adequately. Second, the Town has no control over our infrastructure that happens on that property. Examples are like traffic on the streets, water, sewer and erosion. That is what we are trying to work out with USA Trucking. Lucile also stated that people on 7th Street have water wells. What is going to happen to the wells? Mayor stated that he does not believe any contamination is going on. DEQ is update on what is happening. What the Mayor is concerned is the activity that is adjacent to our borders and affecting our residents. Lucile stated that they have a petition that a lot of people have signed.

Kenneth Bates:

New City of Casper Council Member. He just wanted to introduce himself to all of us. Kevin was there yesterday at the meeting. Sorry we could not get your questions answered. He asked to shake Councilman Wales hand for serving in the service. He asked Councilman McCarthy welcoming her as a new council member. Sara stated that she is not new and has been here for 3 years. He apologize for getting misinformed. He is Ward 2 and that is in a section of Mills. He wants to offer that if we need anything from Casper on their end to reach out to him. Call him, email him. He would love to get with all of us. Any conflicts that we have he would like to work together. He has family in Mills. He visit often and he would like to work together with all of us. He looks forward to the relationship with the Town of Mills.
