The hearing will be conducted in accordance with state statues and has been set and advertised in accordance with the statutes. I would ask those individuals who wish to address the council on this issue to approach the lectern, state your name, and address for the record. Do we have a report on this item? Scott Radden Town Planner stated that on November 15<sup>th</sup>, 2018 a public hearing was held for the consideration of the zone change for Platte View Estates. Town Planner Scott Radden stated P & Z board passed a due pass for the council to consider. Mayor Coleman asked is there was anyone in the audience who wishes to speak in favor of this item. Again, Mayor Coleman asked is there was anyone in the audience who wishes to speak in favor of this item? Then Mayor Coleman asked if there was anyone in the audience who wishes to speak in opposition to this item. No one spoke up. <u>Public Hearing: Special Review Permit to Allow Apartment within an Established Business Zoning District on Lot 1-3 of the Natrona County Business Park.</u>

Mayor Coleman now declared the Public Hearing opened for the consideration of the special review permit to allow apartments within an established business zoning district on lots 1-3 of the Natrona County Business Park. The hearing will be conducted in accordance with state statues and has been set and advertised in accordance with the statutes. I would ask those individuals who wish to address the council on this issue to approach the lectern, state your name, and address for the record. Do we have a report on this item? Scott Radden, Town Planner stated that Cornerstone is here to show a layout and talk about the apartment units. Mayor Coleman asked is there was anyone in the audience who wishes to speak in favor of this item. Brad Schwab and Bobby Jo Lucas were present from Cornerstone. They showed a layout of the apartments. They will be 3 three stories high and consist of 66 units. They will be affordable housing and they are applying for tax credits. Brad stated that they will be a good neighbor and safety is there number one priority. There will be 170 parking spaces and 35 garages. Brad also stated that they will also be the management company as well as the owner of the building. They feel that they maintain better control of the property that way. Brad stated that there is a strong need in this community for this type of units. Cornerstone has over 20 years' experience in building and have been in the management part since 2006. There will be 1 to 4 bedrooms units. Again, Mayor Coleman asked is there was anyone in the audience who wishes to speak in favor of this item. Carl Nelson who owns the property is in favor. He has grown up in Mills and has seen the town grow. The town needs this. Carl stated that since we lost our schools maybe this will help to get them back. He is upset with his industrial friends that are not on board with this project. Again, is there anyone in the audience who wishes to speak in favor of this item? Bobby JO Lucas the owner of Cornerstone stated that they take pride in their work and the apartment buildings are built well and are attractive. They understand some concerns and will work through all of them. Then Mayor Coleman asked if there was anyone in the audience who wishes to speak in opposition to this item. Dan Elrod who owns a lot of property on Falcon. He is not in favor of these apartments coming. There is a lot of semi-trucks traffic in and out all the time. Since the trailer park expanded he has had nothing but trouble. The police department will have record of this. We have had vandalism and trash and things stolen. This area is zoned business and needs to remain that way. Affordable housing will bring in trouble makers and cause more crime to happen. Again, is there anyone in the audience who wishes to speak in opposition to this item? Chris Elrod is also not in favor of the apartments. He works for West Coast Engineered. He also believes that the crime will go up and that their business will suffer. They have been in Mills since 1991 and Mills needs to concentrate on bringing business in that will work for the area. For a third and final time is there anyone in the audience who wishes to speak in opposition to this item. Mayor

Coleman mentioned that after all have spoken and there being no others to speak for or against this item, know declare the public hearing closed at 7:35 PM.

Councilman Ives wanted to clarify some things before a motion was made. Councilman Ives wanted to know if there is going to be some sort of credit check. Bobby Lucus stated that the tenants will go through a background, credit check and check past landlords and a criminal check. Felons are not allowed to rent. The tenant selection will be strict. Councilman McCarthy wanted to know if there is going to some sort of rules for people causing trouble. Bobby Lucas also stated that the rules will be like any other land lord community. There will no junk allowed. All the tenants belongings must be contained in their own unit. There will strict rules for what can be on the property. Maintenance is high on their list. The grounds of the property will be clean and kept up nice. Since they are the management company as well, they take pride in how they run the property. Unfortunate we cannot stop hooligans. Bobby stated that they have a website that people can visit to answers to questions and to see references. The website is cornerstonehousingdevelopment.com.
